saved thanks to the success of firefighters carrying out Home Fire Risk Safety checks according to a recent report.

During a Home Fire Risk Safety Check a firefighter visits a person's home to discuss fire safety and to alert them to the risks of a potential fire.

The report claims that in four years since a £36 million grant to Fire and Rescue Services (FRS) for fire safety, home fire risks safety checks each year have saved 53 lives - a fall of 57 per cent in lives lost through fires.

Also the number of people injured by fire in the home has reduced by 888; and the number of home fires has been reduced by 13,670. See panel for how to book a home visit VI



Ash Green. Baldwin's Hill: Grade II listed application for removal of internal first floor wall - 9 March (registered)

Car park to rear of Enterprise House, 10 Church Hill: Demolition of garages to create six secure parking spaces enclosed by 2.4m high painted timber hoarding. 2 March. **26 Queens Road:** first floor rear extension. First floor rear extension. 27 February.

119 York Hill: Grade II listed building application to convert single dwelling back to two dwellings. Permission granted with conditions. 9

5 Steeds Way: Permission granted with conditions for single storey extension. 3 February.

Noakes Cottage, Steeds Way: Per-

mission granted to prune a conifer, a pear tree, minor prune of holly and privet. 28 January.

11 Baldwin's Hill: Permission granted for first floor side extension, single storey front extension and loft conversion with front and rear dormer windows.

6 Wallers Hoppit: Permission to retain replacement greenhouse granted with conditions.

14 St John's Road: Two and single storey front and rear extensions: revised application granted with conditions..

Woodberrie House, Woodbury Hill: Permission granted for single storey side extension and porch. Subsequent application for discharge of conditions for matching materials and Condition 3

12-18 Pump Hill: Erection of new two storey 3 bedroom dwelling (amendment to previously approved application taking in two instead of single storeys at rear.) Permission granted with conditions.

Woodbury Hollow Cottages: Erection of detached summer house and driveway gates given permission with conditions.

Tree work approved: 29 York Hill, 49 Baldwin's Hill; 2 Potters Close; 94 York Hill: 7 Baldwin's Hill: 61 York Hill; Orchard Cottage, King's Hill; White Cottage, Baldwin's Hill.

Hills Character Appraisal: what it is, what

The Hills Character Appraisal is the most significant piece of work to define and shape the future of the area in which we live since the granting of Conservation Area status 25 years ago. There will be three separate documents for the three individual conservation areas of York Hill and Staples Road—which will be completed first—and then Baldwins Hill. A key part of the process is public consultation and the Hills Amenity Society has sought to involve residents at every stage. We announced the project at our AGM in May 2008, inviting volunteers to join the working group. We carried articles about the project in our Spring-Summer and Autumn-Winter newsletters in 2008 and now the Spring-Summer 2009 edition. We have distributed a questionnaire through our newsletter and on our website; we had a stall at the Loughton Farmers' Market on 5 April 2009. We will update residents at our AGM on Wednesday 13 May and carry the draft for all to see on the Hills website. Later this year the District Council will conduct its own formal consultation on the draft when it is approved by them: until then it is the Hills Amenity Society's "work in progress".

IMPORTANT NOTE: work in progress

There has been close co-operation with Epping Forest District Council, however the project is at this stage work in progress by the Hills Amenity Society Working Group and has no approval or endorsement by the Council or any of its employees.

At this stage only the HAS draft for York Hill is available for discussion. For current draft see

Appraisals for Staples Road and Baldwins Hill will follow shortly.

York Hill Conservation Area

Management Plan 2010-2015

- The council intends to produce a leaflet on the repair and maintenance of historic buildings
- The Council will bring the Article Four Direction currently covering fences and hedges into line with the neighbouring Staples Road Conservation Area to cover materials used on road frontages
- Signs, street furniture and road markings will be brought into keeping with the character of the conservation area. Attention will be paid to out-of-keeping litter bins, seating, bollards and lampposts
- Consideration will be given to frequency of grass cutting, emptying of litter bins and maintenance of trees and hedges on and surrounding the triangular greens which form a distinctive part of the area.
- Consideration will be given to controlling abuse and misuse of forest land within and adjoining the conservation area
- Public consultation on parking, speed and width restrictions
- Discussions will take place with the owners of licensed premises on "neighbourliness"
- An ongoing programme of education will be carried out to encourage residents to help in the maintenance and retention of key characteristics of the conservation area.

Distinctive sub areas within the York Hill conservation area:

- King's Green, with its war memorial and historic buildings, marks the entrance to the Conservation Areas from Loughton High Road.
- School Green, at the junction of Staples Road, Queen's Road and York Hill, with a fine group of weatherboarded cottages. York Hill takes on the character of a narrow country lane, bordered by high hedges
- The triangular York Hill Green at the top of York Hill provides some of the area's most dramatic views across Loughton to Canary Wharf and across the Thames to the Kent hills beyond and is overlooked by some of the oldest properties in Loughton: the Gardeners' Arms public house was originally a cottage dating from the late 17th century.
- Forest Way and King's Hill are steep inclines to the forest
- -Woodbury Hill and Woodbury Hollow, with unmade roads and high hedges, merge the conservation area with the forest

Opportunities for enhancement

- In-keeping bollards, litter bins and seats
- Restriction of indiscriminate parking: more planned parking
- Size and weight restrictions for heavy vehicles to avoid hedge, forest verge, footpath and road damage
- Tighter speed restrictions on roads with no pavements
- Maintenance of roadside holly hedges
- Use of appropriate building materials
- Interpretation for visitors
- Management of trees
- Guidance and intervention on building materials
- More regular clearance of litter and emptying of litter bins

Factors contributing to the character of York Hill Conservation Area

- A number of triangular greens which remain forest land including Kings Green, School Green and York Hill Green
- House plots varying in shape and size
- The steep and dramatic rise of a number of hills
- Tall holly hedges, narrow roads and noticeable lack of pavements
- Houses mainly of two storeys, of Victorian and 20th Century origin, many with unique designs for the area
- A number of older buildings, some dating back to the 17th Century
- The proximity of the forest

The group of volunteers who have been working during the winter to draft the three Character Appraisals for York Hill, Staples Road and Baldwin's Hill deserve thanks and praise.

Those who attended the Amenity Society AGM last year heard how important it was that Conservation Areas were subjected to this review in order to maintain the relevance of their status but it was also clear that our three areas were (for reasons we never quite understood) way down the list of the Council's priorities and, with the minimal Council staffing available for this work, could be several years off.

That was why we decided to do it ourselves with the oversight of the Council officer responsible for these projects.

In this newsletter—and at the April Farmers' Market—we have tried to give a taste of what we are doing. The draft will be on our website for comment and the Council will conduct its own formal consultation when the draft has been tidied up and hopefully approved later this year.
